A FreeStore Note

Happy Thanksgiving from the FreeStore and thanks for your continued support of our mission, helping families start over.

I'd like to give you some rather startling statistics. We've had about a 30 percent increase in demand for services year-to-date over 2022. If you look back over five years, we've seen a 70 percent increase in demand from families in crisis.

But you, our donors, continue to be up to the task. We've had some wonderful gifts and grants, but year after year, it is individual donors who have provided 60 percent to 80 percent of revenue for our all-volunteer charity. We ask for support only twice a year, and only via this newsletter. Elsewhere in this issue is an article on how we use your cash gifts.

Increased demand has also put increased pressure on our volunteers, and they,

too, have come through. Our volunteers drive and load trucks, maintain the warehouse, schedule and greet clients, sort and clean donations, test and repair donations, and coordinate the many tasks that keep us running. I'd also like to direct you to an article that explains why we do this work. Lisa Stagg's story brings home the role we play in helping families start over. As she explains, a visit to our warehouse allows a family to sleep in beds with clean sheets, eat off real dishes, put clothes away in dressers, and begin to heal.

You are receiving this newsletter because you have helped us in the past. Thanks for that, and thanks in advance for any help you can offer going forward.

Spending Your Donations

Several times a week we send twoperson volunteer crews to collect gently used furniture and household items, and thanks to you, those big trucks come back full nearly every time. But clients also need other items, and your donated dollars are used to purchase them.

For example, we never have enough donated vacuum cleaners, microwaves or small appliances to meet client needs. Our volunteer buyers shop for bargains on these items, and stock the warehouse. A couple of years ago a sharp-eyed volunteer landed 200 counter-top microwaves at a big discount.

We continue to buy other items that help clients set up a new home, including bedding, pots and pans, kitchen utensils, mattress protectors, cleaning supplies (every client gets a basket full of paper towels, dish soap, toilet cleaners, and the like), toasters, crock pots, small mixers, and small dressers for kids.

As always, our largest expenditures are warehouse rent and truck maintenance. Also, as always, our budget for salaries is zero, since our entire operation is run by volunteers.

Lisa's Story

Life has changed a lot since that day a dozen years ago when Lisa Stagg picked out household supplies from the FreeStore warehouse and watched as volunteers delivered the goods to her new apartment. Since then she took herself to college, got a great job, bought a house, and centered her life around two lively children.

She still has the plates and a comforter and a few other items she chose at the warehouse that day. "Every time I use them it takes me back to that day. What an amazing experience."

After fleeing an abusive husband and taking refuge in a shelter for several months, an apartment was arranged for

her. "But I had nothing except clothing. Someone at the shelter recommended your service and when I walked in the warehouse, I remember saying that I could use a couple of those things, and the volunteer said, 'You pick out what you need.' It brought me to tears in a good way."

She got beds, a dresser, a couch, kitchen goods, a small television and other items, all delivered that day, all at no cost. "It was a huge weight off my shoulders. I don't know how to put it into words. It was like I was the most important person in the world." she said.

FreeStore Board Chair Diane Munns said it's unusual to get years-later feedback



from clients, and that Lisa's story is an inspiration for our volunteers. "While we know we are just a small cog in the support system necessary for families in crisis to succeed, we are thrilled at Lisa's story and so happy we could be a part of it. Thanks to Lisa for agreeing to share her story."
